RENTAL AGREEMENT

BOOKING

1. Your booking becomes definitive as soon as you:
 - a) Have pay a deposit of 30% of the total cost of your stay by credit card or cheque,
 - b) Have sent, by mail, a signed copy of the agreement to the landlord within 10 days after your booking request.
2. The stay has to be fully paid 30 days before your arrival at the latest. Any client who hasn't paid prior to the due date will have his stay cancelled.
3. In the case of a late booking (less than 30 days before your arrival) the whole amount of the stay will be requested at the time of booking.
4. At your arrival, a 200 € guarantee deposit will be request. This deposit will be return at the end of your stay.

DURATION OF THE STAY

5. Stay: bookings run from Saturday to Saturday - Duration of the stay:
 Arrival: the first day, between 4:30 pm and 6:30 pm
 Please call us to give an estimated time of arrival
 Departure: before 10:30 am on the last day.

CANCELLATION

6. Cancellation by the guests. If you want to cancel your booking:
 - More than 30 days before the beginning of your stay, the deposit 30% deposit is still due (30% of the total amount).
 - Between 14 and 30 days before your arrival: 50% of the stay is charged.
 - Less than 14 days before your arrival: 100% of the stay is charged.

If the cancellation is made by the landlord, this one will return all the sums already paid plus a termination penalty equivalent to the cancellation fee due by the guest if he has the one who where cancelling.

7. Interruption of the stay by the guests:
 No refund possible. You have the possibility to be covered by a cancellation insurance if you have one.

INSURANCE

8. Guests are responsible for any damage caused by them. Please check that you have a personal insurance that includes "holiday" insurance.
 If not, please take out a policy to cover yourselves.
9. The owner has a civil liability insurance from "Assurances AGF", represented by Mr Bruno Rougé, galerie Labrunie 25 rue de Cahors 24200 Sarlat, France.

ACCOMODATION CAPACITY

10. - A maximum of 6 adults + 1 baby can occupy the 3 bedrooms with en suite (2 shower rooms and 1 bathroom).
 - 2 additional people can visit you at any time during your stay, for a maximum of 2 nights, thanks to a sofa bed available.

11. Pets are not allowed in Chantepierre. All bedrooms are non smoking.

TERMINATION OF YOUR STAY

12. Guarantee deposit and inventory of fixtures:

An inventory of fixtures will be done by the landlord and the guests at the beginning and at the end of your stay. A guarantee deposit of 200 € will be asked at the arrival.

CLAIMS

13. Any claim related to the house, the inventory of fixtures or the description has to be submitted to the landlord before the third day of occupancy.

14. Please fill in your comments form before your departure.

15. This agreement is under the French laws regulating the general booking conditions for house rental: sections 95 to 103 of the decree N°94-490 of June 15th 1994.

16. Landlord commitments:

- All the pictures posted on our internet website reflect the actual look of Chantepierre.
- All sheets and other linen are included in the price: bed sheets, both towels, household linen (Pool towels excluded).
- All the beds are made before your arrival.
- Price includes tourist tax.
- A deep cleaning of the house after your departure is included in the price.

17. Your commitments (at the end of your stay):

- Replace all the furnitures as you found them at your arrival.
- All kitchen equipment must be clean and stored away.
- All rooms in the house have to be vacuumed (Basic cleaning)
- All the dirty linen ha to be folded in one of the bed sheets and place in the shower.
- Report all the damages done to the equipment during your stay (soiled linens, Hifi malfunctions, domestic electrical appliances, dishes...).
- Any fees for the damages have to be paid on site after the inventory of fixtures done for your departure.
